Entered into this _____ day of _____, _____, by the City of Greensboro acting by and through its City Manager-Clerk/Treasurer and the undersigned hereby enter into the following agency agreement.

Whereas, the undersigned is applying for a peddler/itinerant merchant license under Section 32-103 of the Code of the City of Greensboro, Georgia; and,

Whereas, pursuant to Section 32-103 (5), as a prerequisite to applying for and being granted a license to engage in business as a peddler or itinerant merchant in the City of Greensboro, Georgia, the undersigned must file an instrument nominating and appointing the City Manager-Clerk/Treasurer his true and lawful agent with full power and authority of acknowledge service of notice of process for or on behalf of the undersigned with respect to any matter connected with or arising out of the business transacted under said license; and,

Whereas, the undersigned is desirous of appointing the City Manager-Clerk/Treasurer as his true and lawful agent for the purposes of acknowledging service notice of process on his behalf.

Now therefore in consideration fo the mutual covenants and undertakings between the parties, the parties agree as follows:

1. The undersigned hereby appoints the City Manager-Clerk/Treasurer of the City of Greensboro, Georgia, his true and lawful agent for all purposes under the above referenced code section;
2. Undersigned consents, agrees and hereby directs that the City Manager-Clerk/Treasurer be made his true and lawful agent and directs that any and all service of any notice of process be made upon such agent and that when so made, shall be taken and held to be a s valid as if personally served upon the undersigned.
3. Undersigned hereby waives all claim or right of error by reason of such acknowledgement of service or manner of service.
4. Upon service of process upon the City Manager-Clerk/Treasurer shall send to the undersigned at his last known address, by registered mail, a copy of said process;
5. Undersigned agrees at all times to provide the City Manager-Clerk/Treasurer with his current address and telephone number.
